### **PAYMENT TERMS**

Goods are supplied subject to 30 day payment terms.

All goods remain the property of Koldpak (QLD) Pty Ltd until the whole of the purchase price, transport and other costs have been paid by the purchaser. **Credit will automatically be suspended if accounts become overdue in excess of forty five (45) days.**

### **PRICES**

Prices and terms are subject to change without notice however advance notice of increases will be provided wherever possible. Purchase orders are accepted subject to the prices in effect at the time of shipment. All prices listed within the Koldpak (QLD) Pty Ltd catalogue are subject to 10% GST.

### **WARRANTY**

All parts distributed by Koldpak (QLD) Pty Ltd are guaranteed against defective material or workmanship. Failure or damage arising from faulty or incorrect installation and fitting will not be warranted by Koldpak (QLD) Pty Ltd. Claims for defective materials or workmanship must be made within 14 days from receipt of goods. In the absence of written/verbal advice within that time, goods will be deemed to have complied with the order.

Koldpak (QLD) Pty Ltd disclaims any liability for labour costs or other damaged parts due to failure of parts supplied by Koldpak (QLD) Pty Ltd or its subsidiaries. All goods sold carry the warranty of the individual manufacturer or re-builder. Wherever possible, the individual manufacturer's or re-builder's warranty policy will be adhere to.

### **RETURN OF GOODS**

No return of goods will be accepted for credit after 60 days from date of shipment from Koldpak.

### **DELIVERY**

Delivery dates where quoted are based upon reasonable estimates. Circumstances beyond our control can affect dates quoted and Koldpak (QLD) Pty Ltd shall be under no liability to the Purchaser for failure to deliver.
